HEALTH & SAFETY POLICY

- ✓ MOTOVARIO S.p.A. undertakes to operate in compliance with the provisions in force in relation to safety, but also to seek continuous improvement of its performance for the protection of its employees and third parties working for it, people living near its the location of its facilities, its own customers as well as for the protection of the environment (business and strategic contest).

✓ MOTOVARIO S.p.A. will cooperate with associations and competent authorities for the development of standards that increasingly adhere to the requirements of the safety and health of workers.

✓ MOTOVARIO S.p.A. will work closely with the local community, demonstrating the its ongoing commitment with regard both to the safety and health of workers and the community and the environment in which it operates.

MOTOVARIO S.p.A. in terms of Safety will also:

✓ maintain a working environment that stimulates and motivates all workers in an effort to reach the goal of zero accidents and possible occupational diseases;

✓ adopt criteria for correct use of natural and energy resources with development of the role of electricity, natural gas, heat, pure or assimilated renewable sources and of water;

✓ promote the application at its premises of Safety Management Systems in line with international standards, conducting appropriate reviews and evaluations to ensure compliance with the company policy;

✓ make known its policy and business strategies when it comes to safety outside the company, through a close dialogue with the authorities, customers, partners and the general public.

All employees of MOTOVARIO S.p.A., as well as the employees of external companies and suppliers, have the responsibility to respect the principles of the above Policy.
